



The Canadian Field-Naturalist Online: Terms and Conditions of Usage

Effective 2020-01-01

These terms and conditions apply to articles in the online version of the Canadian Field-Naturalist (the “online CFN”).

By subscribing to, and/or accessing the online CFN, you agree to be bound by the terms and conditions of this Agreement.

Copyright

The copyright of all content in the CFN is owned by the Ottawa Field-Naturalists’ Club (the “Publisher”) unless otherwise indicated. Issues of CFN are made available via the Biodiversity Heritage Library (BHL) no earlier than six years after publication. All in-copyright CFN content available via BHL for which the Publisher is the copyright holder are available under a Creative Commons Attribution-NonCommercial-ShareAlike 4.0 International (CC BY-NC-SA 4.0) licence

The Licences

Subject to the terms and conditions of this Agreement and upon payment of the annual subscription fee, the Publisher grants to a subscriber to the online CFN, a non-transferable licence for access to all materials included in the online version of the CFN, for the current year of publication.

Subject to the terms and conditions of this Agreement, the Publisher grants to all users a licence for access to all materials included in CFN volumes prior to the current volume.

Terms of access and use

- a) A subscription is required to access the current volume of the CFN. Some content, however, may be accessed upon publication without a subscription;
- b) Access for subscribers and other users is to the full database of the CFN, including tables of contents, abstracts, full text and graphics of all articles, including supplementary files;
- c) Individual subscribers’ access to the online CFN is controlled through the use of a username. Subscribers are responsible for registering for an account on the CFN website, and then supplying the Publisher with the username;

- d) Institutional subscribers' access to the online CFN is controlled through the use of Internet Protocol (IP) addresses. Institutional subscribers are responsible for supplying the Publisher with the name and email address of a primary contact, and valid IP addresses. The Publisher is to be notified of changes within 30 days;
- e) An institutional subscriber may authorize any of its employees, faculty, staff, students or onsite users to access and use the CFN in the same manner as the subscribing institution is entitled;
- f) Any subscriber or other user may search, retrieve, save, download and print copies of individual articles or other items from the CFN database for their scholarly, educational, research or personal use;
- g) Items from the CFN may not be copied or distributed for commercial advantage, nor can any fees or charges be made in connection with such items, without written permission from the Publisher;
- h) Material from the CFN may not be translated, altered, re-compiled, manipulated or used to prepare derivative works, or published in any other format in any medium without written permission from the Publisher, unless (1) the content is made available under a licence that allows such usage and the licence conditions are followed, (2) all rights are waived (CCO), (3) the content is in the public domain, or (4) the content is not subject to copyright.
- i) Author's names, copyright notices, or any other means of identification must not be removed or altered from how they appear in the CFN;
- j) Items from the online CFN database may not be distributed on any electronic network, including the Internet, without written permission from the Publisher or unless they are made available under a licence that allows such usage and the licence conditions are followed ;
- k) All rights not expressly granted herein are reserved to the Publisher.

Unauthorized usage

Institutional subscribers shall take reasonable steps to prevent unauthorized activity by any member of the institution that they become aware of, and to prevent any recurrence thereof.

An individual subscriber is responsible for maintaining security over, and controlling use of, the individual's access, including user ID and password.

Disclaimers

The Publisher:

- a) does not warrant the accuracy or completeness of any information contained in the CFN, nor the availability of access to the CFN continuously, or at any given time;

- b) will have no liability to any person for any loss or damage arising out of use of, or inability to use or access the CFN;
- c) reserves the right to modify the terms of this Agreement immediately by providing notice online and directly to institutions by electronic and conventional mail. Continued use of the CFN for more than 30 days after such notice shall constitute acceptance of such modification;
- d) The opinions, claims, and conclusions expressed in the articles published in the CFN are those of the authors. They do not necessarily reflect the views or opinions of the Ottawa Field-Naturalists' Club, its editors, or reviewers. The research and theories presented in these articles are solely the claims of the contributing author(s). The Publisher assumes no responsibility for damages arising from the use or misuse of information contained in these articles.

Duration of the Agreement

This Agreement becomes effective upon a subscriber completing a subscription request, or upon a user accessing the CFN, and does not terminate.

Access to the CFN will terminate, or be terminated as follows:

- a) At the end of a paid subscription period if the subscription is not renewed, then subscribers who don't renew will still have access to the Volumes they subscribed to and to the CFN archives;
- b) Upon a breach of this Agreement that has been uncorrected within thirty (30) days of the Publisher sending notice that the alleged breach has occurred, and in the discretion of the Publisher. No refund will be provided to a subscriber upon such termination;
- c) Following notice from a subscriber or other user not accepting changes to the Agreement. A refund for the remaining subscription period will be sent to any such subscriber.
